"That Carlow County Council calls on The Health Service Executive to set up a PrEP Clinic in Carlow Town."

PrEP stands for pre-exposure prophylaxis. PrEP is taken by HIV negative people before having sex (pre-exposure) and after sex, to prevent HIV (this is called prophylaxis).

PrEP has been shown in many studies to be safe, and when taken correctly, highly effective at preventing HIV.

PrEP is the newest HIV prevention tool available and is best used in combination with other HIV prevention measures.

While PrEP does not protect against STIs such as syphilis, chlamydia, gonorrhoea and hepatitis C, PrEP users can combine condoms and PrEP to reduce the risk of contracting other STIs.

The nearest PrEP clinic to Carlow is Portlaoise and the clinic has a waiting list of over 125 clients who cannot gain access to PrEP. In Ireland it remains illegal to purchase prescription medication online without a prescription."
